**START OF UNAPPROVED MINUTES** for the 2/8/10 Meeting:  
Meeting convened at 7:00 pm. All Board members were present and 8 members.

The January Minutes and Treasurer's report were approved. The Treasurer presented a budget based on annual spending in the past, the only item changed was training, as BGC will have a much more active NRA training schedule in 2010.

**New Business:**

Range Safety Certificate (RSC). The RSC was mailed to every member with the dues so that they could read the rules and sign a form indicating they had read and understand them. About 50 members did not return the form. The Board decided that next year that returning a signed form will be necessary to be renewed. If it is not received by the Club by close-of-business on January 31, the member will be dropped from the roster.

Orientation: Sholar Powell reminded every one that prospective members must either attend registration or make arrangements to have their payment in by February 12.

Membership Cap: There was discussion about Life Members included in the membership cap. There are several that we do not have current information on and are no longer active. The Board decided to set the membership cap at the current level (375), but not include the Life Members in that cap. As the Life members pass away their memberships will also expire.

Ed Weingart informed the Board that the Single Action Shooting Society had requested that they be named as "additionally insured" on our insurance policy. The Board requested more information on the subject before any action is taken.

There was one conflict noted on the Club calendar (the August workday will move from 8/14 to 8/21) and a schedule change for the Club All Around shoot from 5/29 to 6/19 (corrected Calendar is in this newsletter)

**Old Business:**

There was much discussion about the proposal to purchase new skeet and trap machines, the entire package would cost \$41,000. It was pointed out the skeet revenues currently exceed the cost of targets by approximately \$3000 annually. An increase in the cost of a round of skeet from \$2.25 to \$2.50 would bring in approximately \$2000 annually. In addition the Board decided to raise the amount charged for non-members and outside groups using the facilities to \$5/round. The Annual Azalea Open skeet tournament will charge \$3/round for all targets shot. Thus the Board voted to do the following in order to purchase the new machines:

Appropriate \$10,000 towards the purchase of the machines. Authorize the Treasurer to secure a loan for the remaining amount. Sell the current machines for approximately \$8000 and put that towards the principle of the loan. The annual excess monies generated by the member skeet rounds and other shoots will help defray the loan. Motion made by Brame; seconded by Caison. Motion passed unanimously.

**Election of Officers:** The following slate of officers was elected by acclamation for 2010:

Treasurer: Don Pelling  
Secretary: Dick Brame

A plaque was presented to John Scott thanking him for his outstanding service to the club as president for the past 5 years. He also received a standing ovation.

Meeting adjourned at 8:30 pm.

I am sure under the leadership of our new president and VP, Ray Campbell and Jim Caison, our club will continue to improve with the help of our diversified membership that includes tradesmen and professionals in all areas of construction, engineering and legal and "SWEAT" from everyone.

We should all give a special thanks to Dick Brame and Don Pellin our club secretary and treasurer for the great job they do month after month and year after year and as our membership increases so does their work load. You can also help anytime a trash can needs emptying or wind blown trash needs to be picked up. A little effort by everyone will leave the facility in better condition after each use.

I would like to take this opportunity to say how proud I am to have served as BGC president and feel that we accomplished good things during those few years. I might also say that every thing I have given in time and energy to the club has been return ten fold, so join me in future projects.

## **MEMBERSHIP NOTICE - Annual Dues/NRA/Range Safety Certification:**

Effective with the 2011 Dues & Workday Assessment, which will be mailed out with the December 2010 newsletter, each member is required to provide three items back to the Club:

1. Check for the correct amount of annual dues and any workday assessment stated on the invoice.
2. Proof of current NRA membership; either a photocopy of your membership card or a mailing label from your NRA magazine showing both your NRA ID number and a non-expired expiration date.
3. A signed Range Safety Certification form.

Failure to include any of these items will result in your payment being mailed back to you for inclusion of the correct info. In the event your payment is close to January 31, and you are unable to get the correct payment/info in the hands of the Club by January 31, your name will be dropped from Club rolls, and your membership terminated.
